# LAS VEGAS HIGH SCHOOL ALUMNI ASSOCIATION MINUTES OF BOARD OF DIRECTORS MEETING – 04/29/18

A meeting of the Las Vegas High School Alumni Association ("LVHSAA") Board of Directors was held at Patty Haack's home. Directors Allen Kaercher, Maria Konold and Laura Ungaro were unable to attend. The following board members, representing a quorum, were present.

President Rollie Gibbs opened the meeting and then asked Patty Haack, Secretary/Treasurer, to conduct the remainder of the meeting.

## **Minutes of Prior Meeting**

The minutes of March 11, 2018 meeting were unanimously approved by attending board members.

## **Replacement of Board Members**

We still have two open positions on the LVHSAA Board. A motion was made and unanimously approved to elect Crystal Latham Beville to one of the open positions. Jill Leone, who resigned due to family issues, may be re-joining the board soon. We have another candidate that we will be considering at our next meeting, which would bring the total board members to 11.

## **Financial Report**

The LVHSAA Income and Expense Statements and Balance Sheet as of 04/29/18 were reviewed and unanimously approved by the board. There were no unpaid expenses.

Patty reviewed the research she did on CD and checking account interest rates. The board agreed it was not worth making a change at this time.

## 2018 Budget

The 2018 budget was reviewed and unanimously approved by the board. There were no significant variances.

## **COMMITTEE UPDATES**

## Fund Raising

Rollie, Bruce and Allen met recently at the Las Vegas Academy to scope out the space for Allen's proposed fund raiser which will probably be held in 2019. Allen was not able to attend our board meeting, so further discussion on his proposed fund raiser was deferred until our next meeting. Patty reported that we made \$1776 for the scholarship fund since our March meeting - \$1381 in donations, \$245 in memorabilia sales and \$150 in yearbook sales.

## Membership

We gained 4 new members (3 lifetime and 1 annual) and 26 renewals since the last meeting. Two members passed away during the last month. We currently have a total of 280 paid annual members and 177 lifetime members, plus 8 honorary members and 19 free members, for a total of 484 members in good standing. We still have 52 memberships that expired at the end of last September. We discussed ideas on how to increase membership. Bruce and Maria will be calling some of the members whose memberships have expired. Debbie Brockett advised that there are 27 LVHS staff members that are LVHS alumni. She will provide a list of names so we can contact them about joining the LVHSAA.

## Scholarships

We received a total of 52 applications and awarded a total of \$20,000 to ten students. We made a few changes to our procedures to make the review process easier next year. Letters have been sent to each recipient, and we will be presenting framed certificates to the ten recipients at Senior Awards Night on May 1.

#### Grants

Since the March meeting, we paid for 23 caps and gowns and donated \$1400 to assist students in need.

Debbie advised that she will be sending a new request soon to assist homeless/needy students.
