LAS VEGAS HIGH SCHOOL ALUMNI ASSOCIATION MINUTES OF BOARD OF DIRECTORS MEETING – 10/22/17

A meeting of the Las Vegas High School Alumni Association ("LVHSAA") Board of Directors was held at Patty Haack's home. Directors Lisa Ball, Laura Beverlin Chadburn and Laura Ungaro were unable to attend. The following board members, representing a quorum, were present.

President Rollie Gibbs opened the meeting and then asked Patty Haack, Secretary/Treasurer, to conduct the remainder of the meeting.

Minutes of Prior Meeting

The minutes of September 10, 2017 meeting were unanimously approved by attending board members.

Financial Report

The LVHSAA Income and Expense Statements and Balance Sheet as of 10/22/17 were reviewed and unanimously approved by the board. The board approved the payment of \$198.29 for repairs on the vehicle recently donated.

2017 Budget

The 2017 Budget was reviewed and unanimously approved by the board.

Preservation and Renovation of the Las Vegas Academy Main Building and Gymnasium

The final feasibility study report has been received. Bruce personally delivered copies to the three local architectural firms and other parties involved with this project. A public meeting with presentations by the three architectural firms was held in the Lowden Theater on October 12. Bruce will be attending additional meetings with representatives of the school to make the final selection of the architectural firm.

COMMITTEE UPDATES

Fund Raising

Bill Boyd made the high bid and purchased the Roy Purcell painting of the history of LVHS, and he has donated the painting to the LVHSAA. Patty reported that we made \$10,165 for the scholarship fund since our September 10 meeting, including three "in memoriam" donations, program ads, memorabilia sales and the raffle at the Wildcat Reunion, plus almost \$2000 in donations received along with Wildcat Reunion reservations.

Bruce introduced guest Jeanne Hamrick, a senior executive with JBH Link, a fundraising consulting group, who made a presentation and proposal to the board on setting up a fund raising campaign. This will be discussed further at our next meeting.

Membership

Having not signed up any new members at the last two Wildcat Reunions, the board decided we would not have a table for membership sign-ups and renewals next year. We will still do the membership challenge, which will be promoted with the annual mailing for the Wildcat Reunion. The trophy will be awarded to the class with the most members as of the date of the reunion.

We gained five new members since the last meeting (classes of 1953, 1955, 1956, 1955, and 1965), including one new lifetime member. 22 renewals were received. We currently have a total of 182 paid annual members and 168 lifetime members, plus 8 honorary members and 9 free members, for a total of 367 members in good standing (down from 519). Numbers are lower than last month due to memberships that expired at the end of September. A reminder will be included in the next newsletter, plus a postcard reminder will be sent to those still not renewed by December.

Wildcat Reunion

The Wildcat Reunion was a big success even though attendance was down from 2016. Next year's reunion will be on September 29, 2018. Committee meetings will begin in late March, 2018.
